- I found out that Hillsboro posts the leagues Red Cards on their site every season. They include first name, but not last name of the player carded. Oddly enough they also include the first name of the Referee also.
- I have been maintaining an active list of players red carded on a hidden part of our website for Referee's to access. I have not been included in suspension details (i.e. the length of suspension) so I have been going off our "chart" to gauge if players are "off" their suspension or not. Every player is listed on this list, but those who are not suspended any longer have a strikethrough their text. This is for the referees to access and be informed of the names of currently suspended players so that they may have that name in the back of their heads. Ultimately it is still the player and managers responsibility to make sure a suspended player does not play. If the referee lets a suspended player play because that player illegally has a card, its not the fault of the referee.
